## Background to SBCF

The Scottish Borders Construction Forum has been set up to discover how best to help and assist Borders Trades People, Local Businesses and Trade Suppliers (as individuals or collectively) to make more of the opportunities that the transition into energy efficiency and net zero will offer. Such a forum existed before, and its loss has left a noticeable vacuum.

In 2021 a wide range of likeminded individuals, organisations and agencies came together to set up Scottish Borders Construction Forum.

The Forum aims to provide a central point for all construction sector businesses, organisations, sole traders and associated bodies to share information, provide training opportunities and keep the sector informed on market changes.

There is an urgent need to look ahead and establish how to best prepare for future opportunities, especially with regard to the impacts of climate change on the construction sector and through PAS 2030/35

To date the Forum has held 10 Steering Group Meetings, produced a series of 12 Webinars, circulated over 3500 information fliers through trade outlets, events and direct to tradespople and provides regular industry news through its Facebook Page.

Planned for 2023 are training opportunities and Steering Group Meetings. Like our Facebook page to stay informed.

Our aim is to support local people to work locally and to benefit from the opportunities that energy efficiency will bring.

## New Heat Pump Mobile Training Centre

#### Installers can now receive certified heat pump training anywhere in Scotland!

A new BPEC certified approved mobile training and assessment facility, hosted by South Lanarkshire College is now available to colleges across Scotland to provide heat pump training to heating installers. The service will focus on rural and remote areas and places where there isn't currently college training provision. The mobile centre will also act as an extra training facility for colleges responding to surplus demand for heat pump training.

Installers will be able to visit the mobile centre to be trained and certified on heat pump installations and also to gain their Water Byelaws/Regulations and Domestic Vented and Unvented Hot Water Storage qualifications.

Primarily the centre will be used by colleges to deliver heat pump training. When not in use for training, other organisations with a legitimate purpose can use the training centre. <u>https://heatpumpinstallertoolkit.org</u>

# Scottish Borders Trades Subsidy Scheme Fund Details

In the Scottish Borders Construction Forum 2022 Trades Survey, 93% of traders stated that they would be willing to undertake energy efficiency training if funds were available and 91% said they needed a training subsidy to cover loss of earnings.

Many sole traders and micro businesses stated that the cost and time needed for up-skilling were barriers to uptake as most didn't qualify for support schemes such as the CITB levy.

To target specific skill shortages we requested funds from **UK Shared Prosperity Fund** for a modest training budget which covers both training fees and loss of earnings.

We are delighted to announce that our application was successful and have secured funds to take 8 non-VAT Registered sole traders / businesses through training.

The following courses are eligible for funding:

- EV Charging
- Ground Source and Air Source Heat Pumps
- Unvented Hot Water Systems
- PAT Testing
- Solar Thermal
- Solar Photovoltaic

## Terms of SBCSTSS Fund

- Each person/business is limited to 1 application to the fund
- Your business address must be registered in Scottish Borders
- Applications will be considered on a first come, first served basis
- The loss of earnings fund can only be used for course training days


#### 21st September, 9.30-12.30. Productivity Workshop, Selkirk.

The MCS Certification Fund provides heating engineers with funds to pay their first-year fees to become MCS certified on heat pumps. The grant pays 75% of the certification fees up to £1,000 and runs until the end of March 2024 while funding lasts.

# Energy Efficient Supply Chain SPF Funds Awarded

The Southern Uplands Partnership (SUP) has been awarded a grant from the UK Shared Prosperity Fund to undertake five projects around energy efficiency, supply chains, supplier development, education and skills.



Under Activity I we will continue to develop the Borders Construction Forum (BCF), bringing together all those with an interest in sustainable construction, retrofitting, green and energy efficient homes and the supply chains necessary to support these. The BCF is chaired by Borders College.

This project is funded by the UK government through the UK Shared Prosperity Fund. Under Activity 2 the project will provide fully funded training in key skills areas to at least 8 existing local contractors to allow them to deliver new retro-fitting services. We will continue to work with other stakeholders to promote the need for these skills, the opportunities for training and the barriers that are faced by those wanting to up-skill.

Under Activity 3 the project will explore the need for and possible structures of, a system to support collaboration between small businesses so they can bid for and deliver larger retrofitting contracts. A social enterprise may be the answer.

Under Activity 4 we plan to work with the Local Home Energy Efficiency Strategy (LHEES) team to establish a pilot where a number of typical "able to pay" Borders homes can be retrofitted together as a way of reducing costs and delivering energy savings at scale. This would be monitored closely to ensure lessons are learnt and shared.

Under Activity 5 the project will aim to grow the work already started making young people aware of the opportunity for quality jobs in the sustainable build environment sector. Working with schools, DYW, colleges and universities, we will organise insight days and taster sessions we will engage with young people, their parents and teachers.

## Energy Performance Certificate (EPC) reform: consultation

The purpose of this consultation is to set out the Scottish Government's final proposals for EPC reform and to seek stakeholder views ahead of the introduction of new legislation. Following this consultation, SG intend to introduce revised Energy Performance of Buildings (Scotland) Regulations to the Scottish Parliament in Winter 2023-24, subject to the necessary legislative vehicle being in place. This would mean that revised EPCs can come into force shortly afterward.
